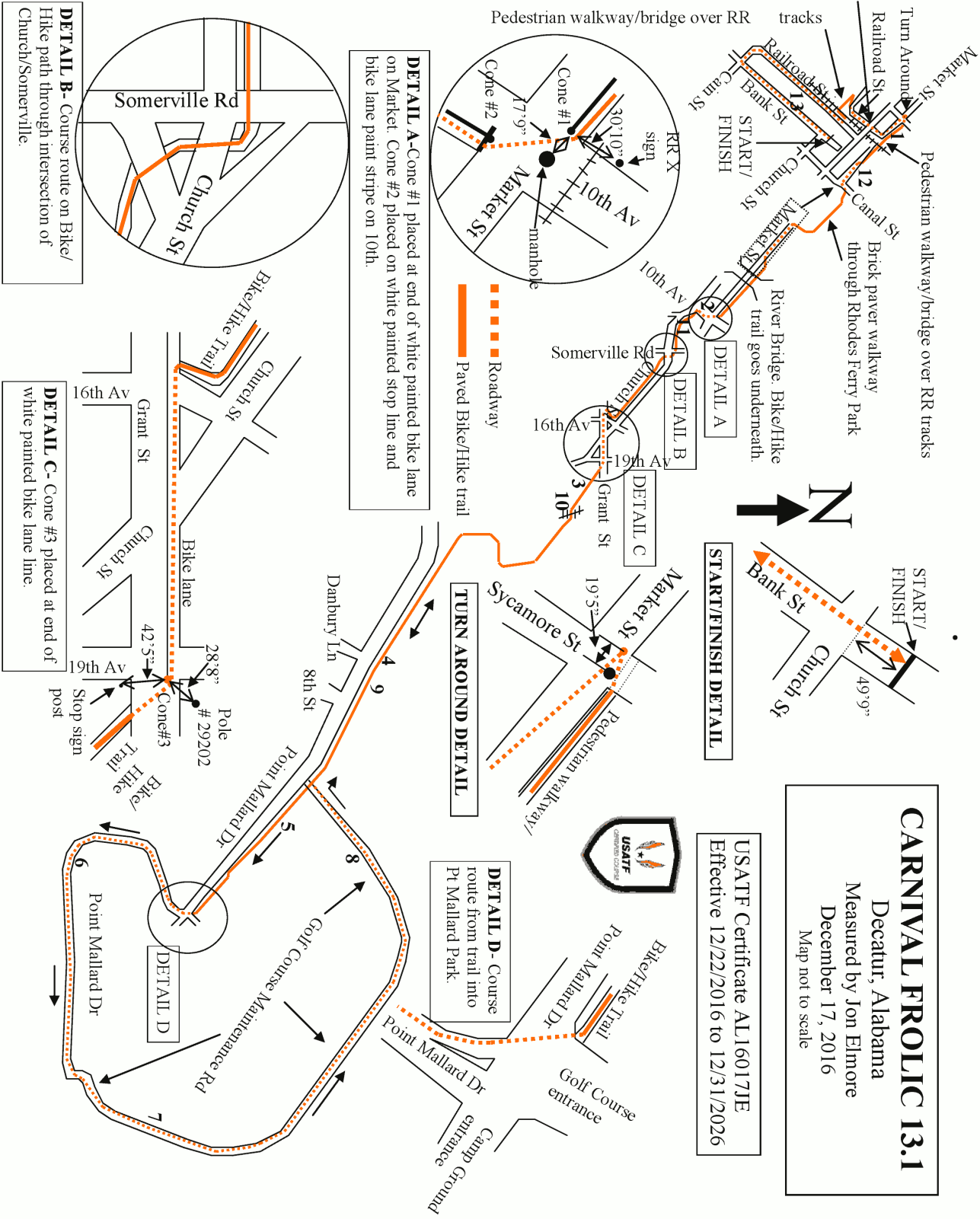

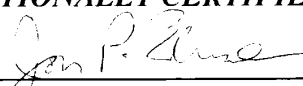
Be It Officially Noted That

Carnival Frolic 13.1

Decatur, Alabama / AL16017JE

Start/Finish- Bank St access street to Old State Bank, 49'9" northeast of cement/asphalt seam at entrance gates.

Turn Around- Intersection of Market St/Sycamore St, 19'5" northwest of manhole cover in intersection.

1 mile- On bike/hike trail ramp to pedestrian bridge over railroad tracks, 29'7" southeast of yellow pole at entrance to ramp.

2 mile- 10th Av between Wilson St and Church St in bike lane, 17'4" north of water meter in median at Spenco Fuel Depot.

3 mile- On bike/hike trail just past Grant St entrance to trail, 6'6" west of utility pole with orange painted 3 on it.

4 mile- On bike/hike trail across from intersection of Point Mallard Dr and Danbury Ln, no permanent landmark to measure from.

5 mile- On bike/hike trail approximately 150 yards southeast of back entrance to Point Mallard Golf Course, 3'8" east of yellow gas pipeline marker.

6 mile- Point Mallard Drive across from Lazy River Bldg., 20'2" east of electric box in grass at roadway edge.

7 mile- Golf Course Maintenance Rd at second creek outlet from golf course to TN River, 13'10" north of culvert pipe under roadway.

8 mile- Golf Course Maintenance Rd approximately 50 yards southwest of entrance to gravel trail, no permanent landmark to measure from.

9 mile- On bike/hike trail just past Walley World at Point Mallard Dr/8th St, between first two electric power towers on roadside, no permanent landmark to measure from.

10 mile- On bike/hike trail 59'5" northwest of railroad tracks that cross trail.

11 mile- On bike/hike trail between Somerville Rd/10th Av, 72' east of utility/pole #22258

12 mile- Intersection of Market St/Harborview Dr, 9' east of cement sidewalk/asphalt seam.

13 mile- 709 Bank St (GBW Architects), 2' south of electric box under bench in front of business.
