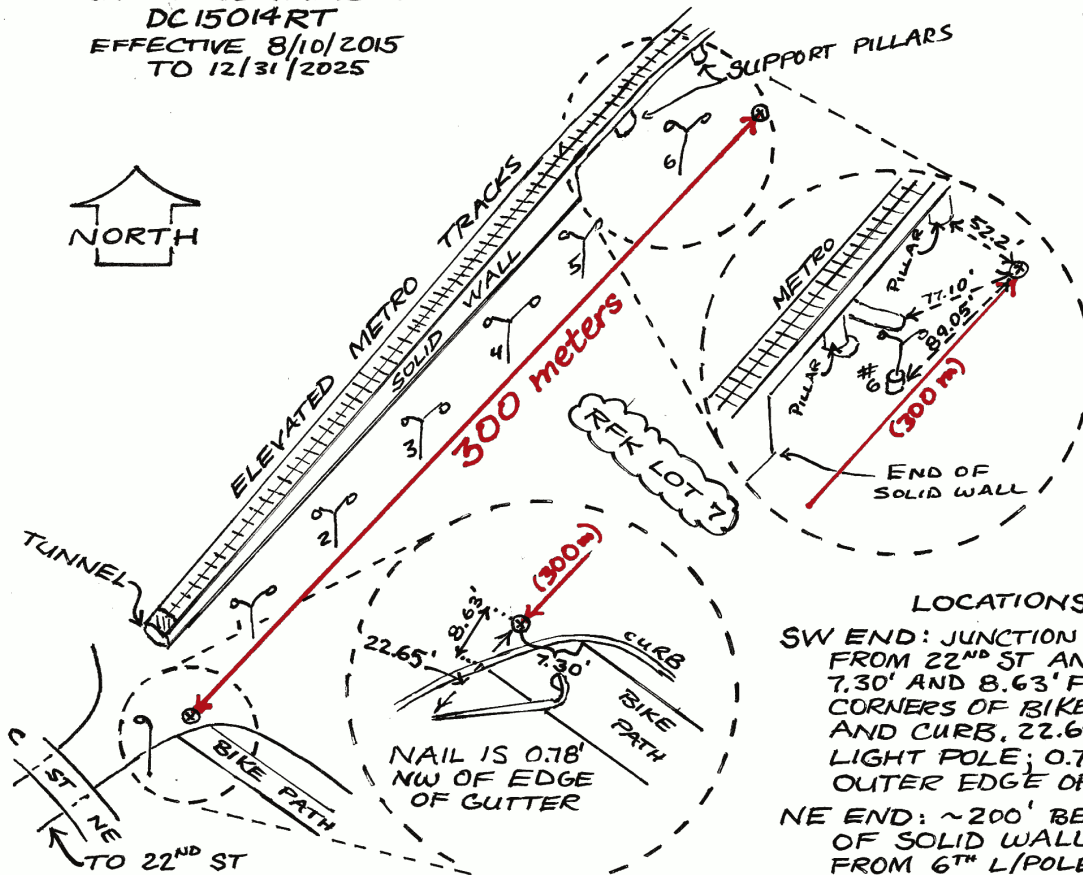

MAP NOT TO SCALE



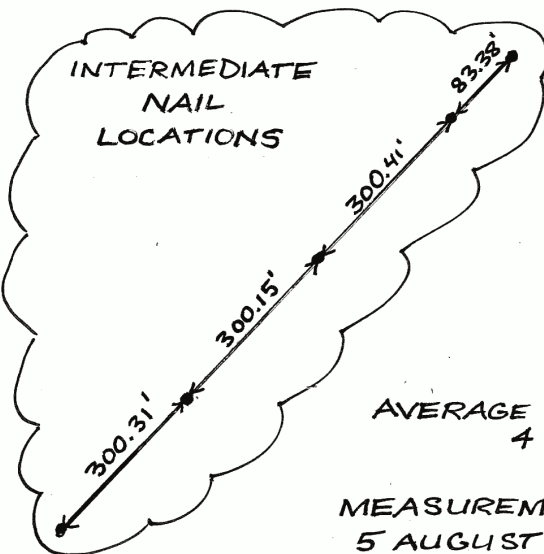
LOCATIONS

SW END: JUNCTION OF D/WAY FROM 22ND ST AND LOT 7; 7.30' AND 8.63' FROM N & S CORNERS OF BIKE PATH AND CURB, 22.65' FROM LIGHT POLE; 0.78' FROM OUTER EDGE OF GUTTER.

NE END: ~200' BEYOND END OF SOLID WALL; 89.05' FROM 6TH L/POLE; 77.10' FROM TRAFFIC ISLAND; 52.2' FROM 2ND SUPPORTING PILLAR.

NOTES: ENDS MARKED WITH "MAGNAILS" AND "+" SIGN (WHITE PAINT).

ALIGNMENT: RIDING SW, COURSE ALIGNED WITH LIGHT POLE NEAR BIKE PATH. RIDING NE, CLOSE ALIGNMENT WITH A SUPPORT PILLAR FOR METRO TRACKS IN NORTH PORTION OF LOT #7.
