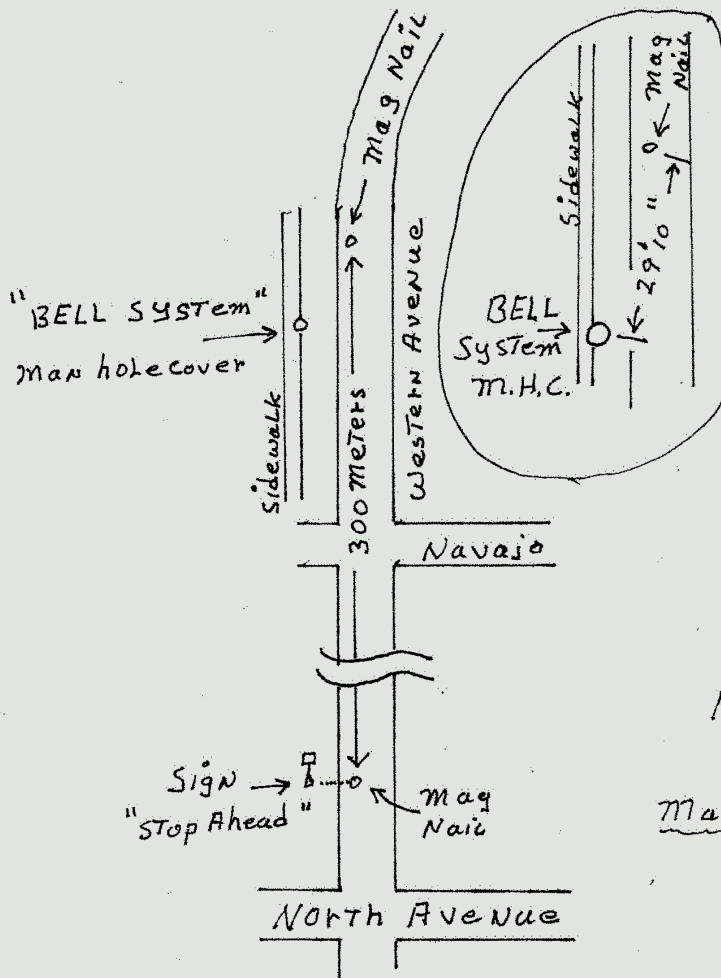


Be It Officially Noted That
