Mile 3: Facing South on the Boulevard. 36 feet 7 inches North of UP JC124PK and the Pompton Plains Reformed Bible Church #415 (Pompton Plains, NJ). Mile 4: Facing South on the Boulevard. 57 feet 4 inches South of UP JC1224PK across from Tony's Blvd Service Ctr. #276 (Pompton Plains, NJ).

Mile 5: Facing South on the Boulevard, 10 feet North of UP JC1241PK (Pequannock, NJ).

Mile 6: Facing East on Mandeville Ave. 43 feet east of UP JC1316 SOLID in front of House #71 (Pequannock, NJ).

Mile 7: Facing South Comly Road. 18 feet 4 inches north of UP JC457LP (Lincoln Park, NJ).

Mile 8: Facing North above the intersection of West William and Bog & Viy Ln. 41 feet 9 inches North of UP ABT37PH at House #41 (Lincoln Park, NJ).

Mile:9: Facing West on John Street. 44 feet 6 inches West of UP BT230LP across from House #20 (Lincoln Park, NJ).

Mile 10: Facing North just before the Jacksonville Rd intersection. 45 feet 4 inches north of UP JC628PK (Pequannock, NJ).


Mile 11: Facing East in the intersection of Andrews and Kinney Place. 49 feet 1 inch East of UP JC391PK (Pompton Plains, NJ).

Mile 12: Facing West on Mandeville Ave. 40 feet 3 inches West of UP JC1317PK (Pequannock, NJ).

Mile 13: Facing South West on Ackerson Ave. 25 feet 8 inches northeastt of UP BT664PK (Pequannock, NJ).

Finish: Facing West on Ann Place. 79 feet 1 inches around the comer to the east start of the start line at UP BT1114PK or 70 ft 2 inches as the crow flies through the bushes adjacent the sidewalk to UP BT1114PK. Finish is marked with a large "F" in front of #6 Ann Pl.
