


# Conklin Calibration Course

At north end, nailswashers are in center of and also at E edge of shoulder, in line with center of fire hydrant.

At south end, nail/washers are in center of and also at E edge of shoulder, in line with center of utility pole 221S NYT.

Course length: 306.2701 meters

Course located on Conklin Road, N.Y. Route 7, in Conklin, N.Y. The Conklin Town Hall is 0.93 miles N of intersection of Conklin Road and N.Y. Route 20, also known as the Conklin-Kirkwood Bridge Road.
