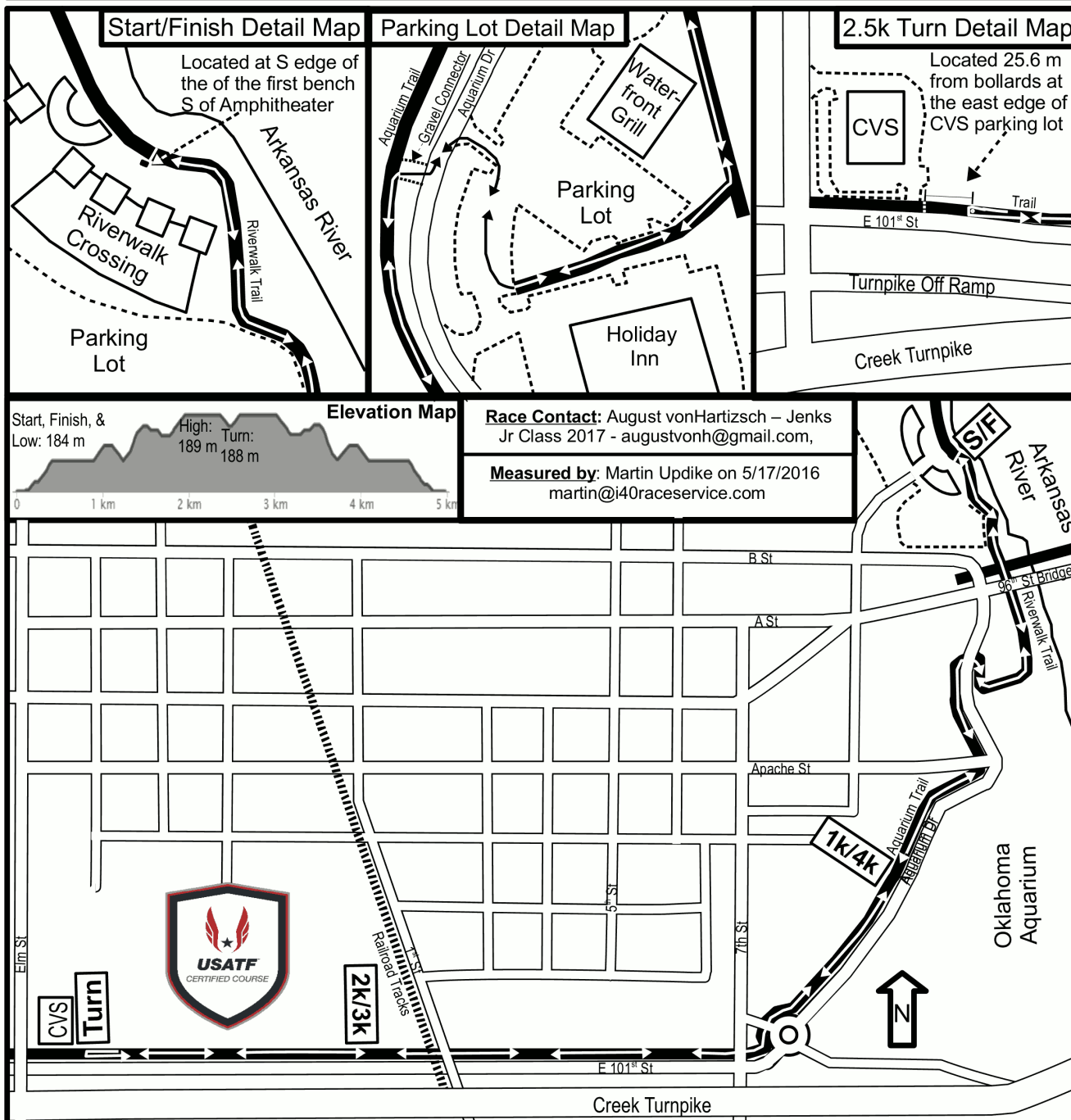


Start/Finish: On Jenks Riverwalk Trail, located directly in line with the south edge of the first bench south of the Riverwalk Crossing Amphitheater

2k/3k: On Aquarium Trail, 78.6 m west of the bollards on the west side of the railroad crossing

2.5k Turn: On Aquarium Trail, 25.6 m east of the bollards at the east edge of the CVS Pharmacy Parking Lot.
