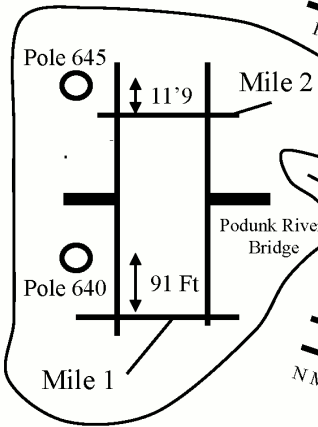
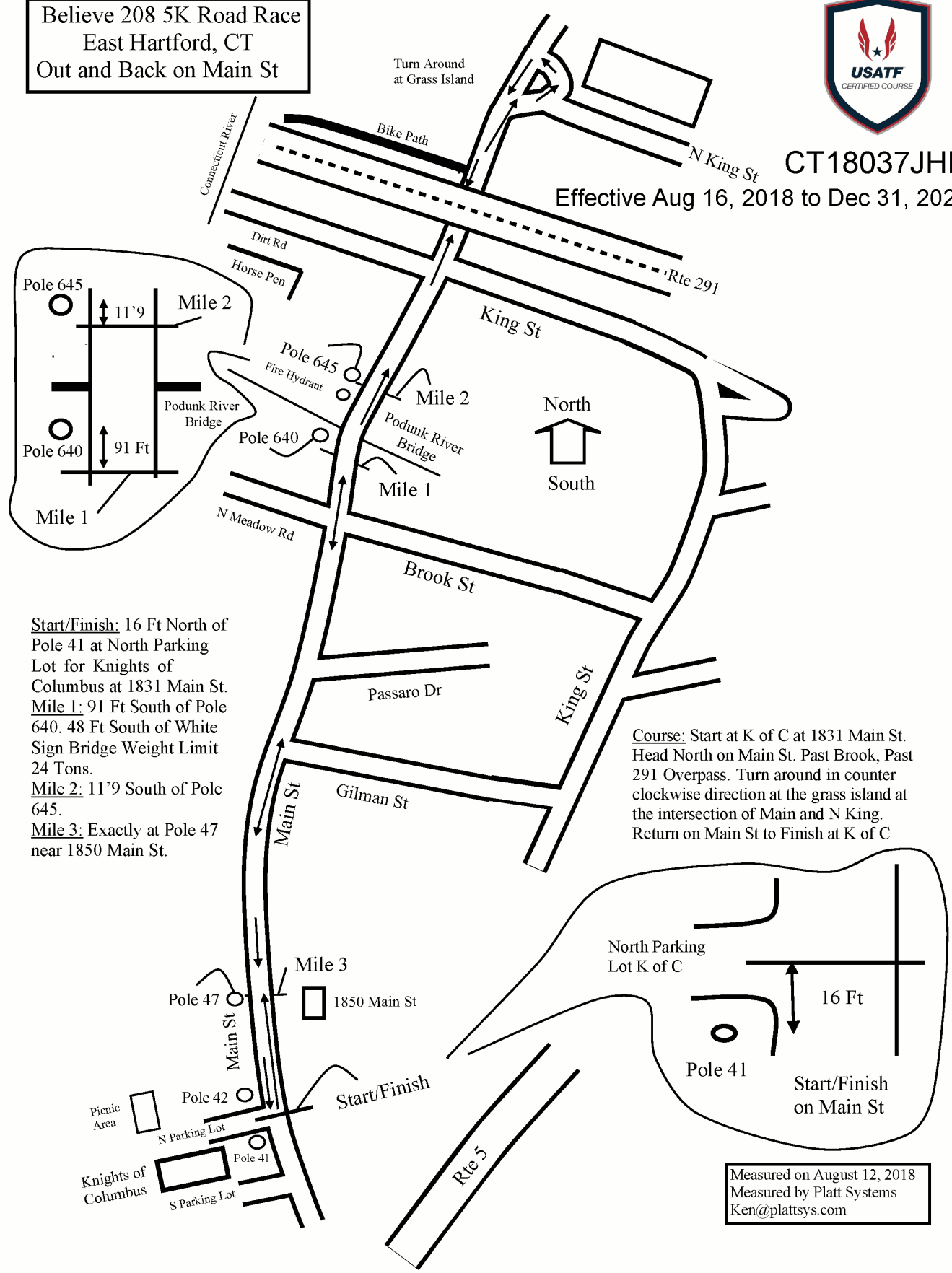

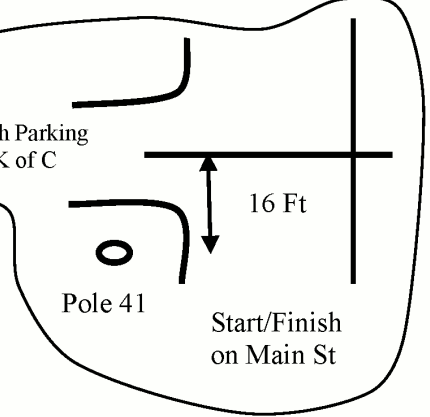

Mile 2: 11'9 South of Pole 645.
Mile 3: Exactly at Pole 47 near 1850 Main St.

Course: Start at K of C at 1831 Main St. Head North on Main St. Past Brook, Past 291 Overpass. Turn around in counter clockwise direction at the grass island at the intersection of Main and N King. Return on Main St to Finish at K of C
