Start – On Magnolia Street, 5 feet 6 inches south of the north edge of the building at 132 Canal Street, even with the white stop line.

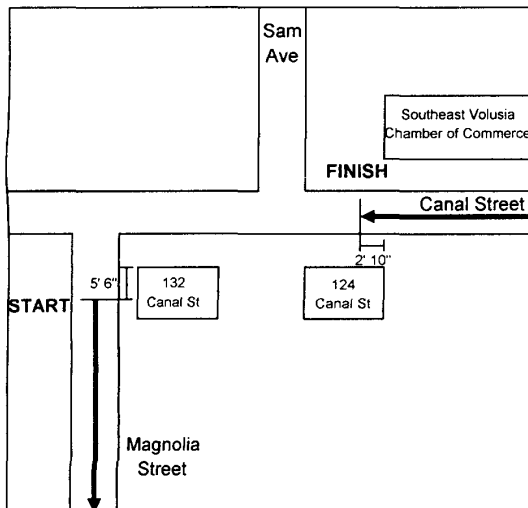
Mile 1 – On Magnolia Street, 3 feet 4 inches south of the north edge of the house at 1315 Magnolia Street.

Mile 2 – On Riverside Drive, 99 feet south of the stop sign at the intersection with 6th Street.

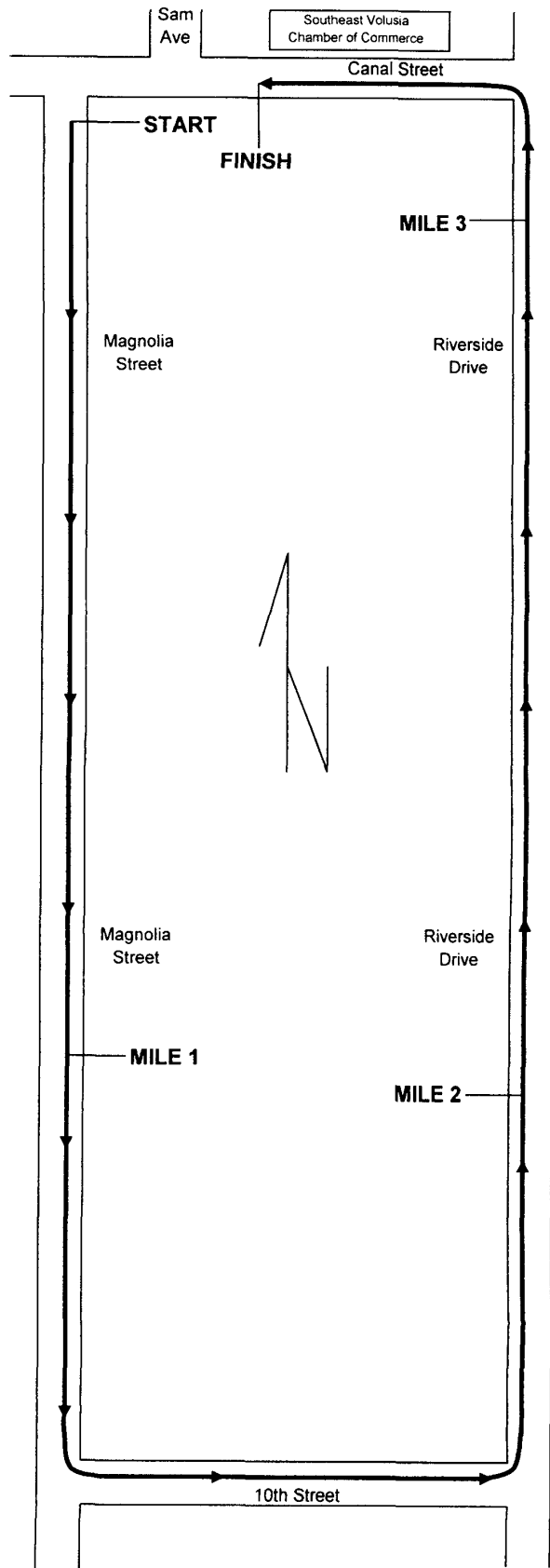
Mile 3 – On Riverside Drive, 1 foot 3 inches south of power pole # UC 3043.

Finish – On Canal Street, 2 feet 10 inches west of the east edge of the building at 124 Canal Street.
