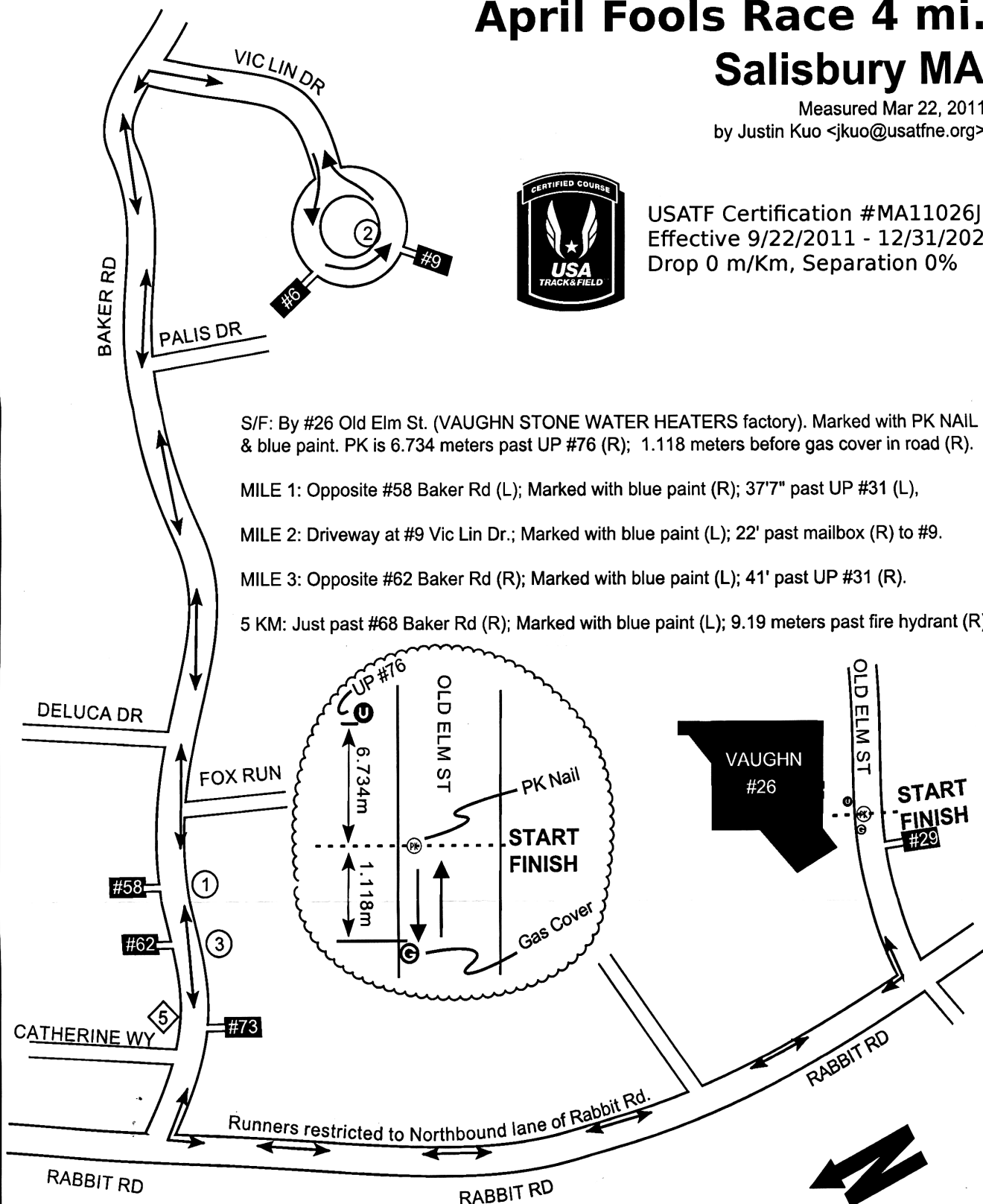

MILE 1: Opposite #58 Baker Rd (L); Marked with blue paint (R); 37'7" past UP #31 (L),

MILE 2: Driveway at #9 Vic Lin Dr.; Marked with blue paint (L); 22' past mailbox (R) to #9.

MILE 3: Opposite #62 Baker Rd (R); Marked with blue paint (L); 41' past UP #31 (R).

5 KM: Just past #68 Baker Rd (R); Marked with blue paint (L); 9.19 meters past fire hydrant (R).
