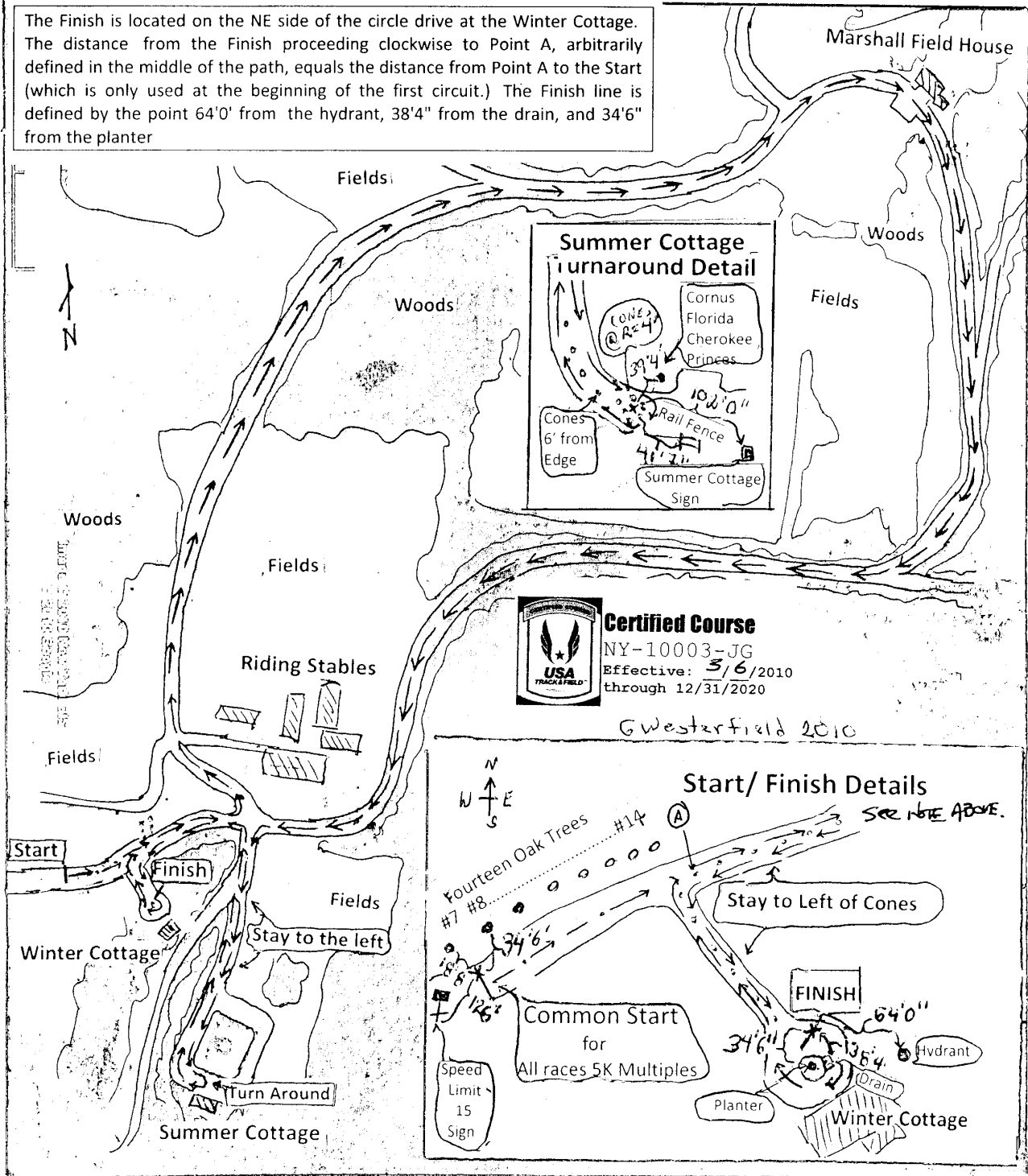


# CAUMSETT HISTORIC PARK 5K CIRCUIT

LLOYD NECK, HUNTINGTON, NY (5x=25k, 10x=50k)

The Finish is located on the NE side of the circle drive at the Winter Cottage. The distance from the Finish proceeding clockwise to Point A, arbitrarily defined in the middle of the path, equals the distance from Point A to the Start (which is only used at the beginning of the first circuit.) The Finish line is defined by the point 64'0" from the hydrant, 38'4" from the drain, and 34'6" from the planter
