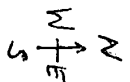


DIVAS half marathon at Long Island East Meadow, NY

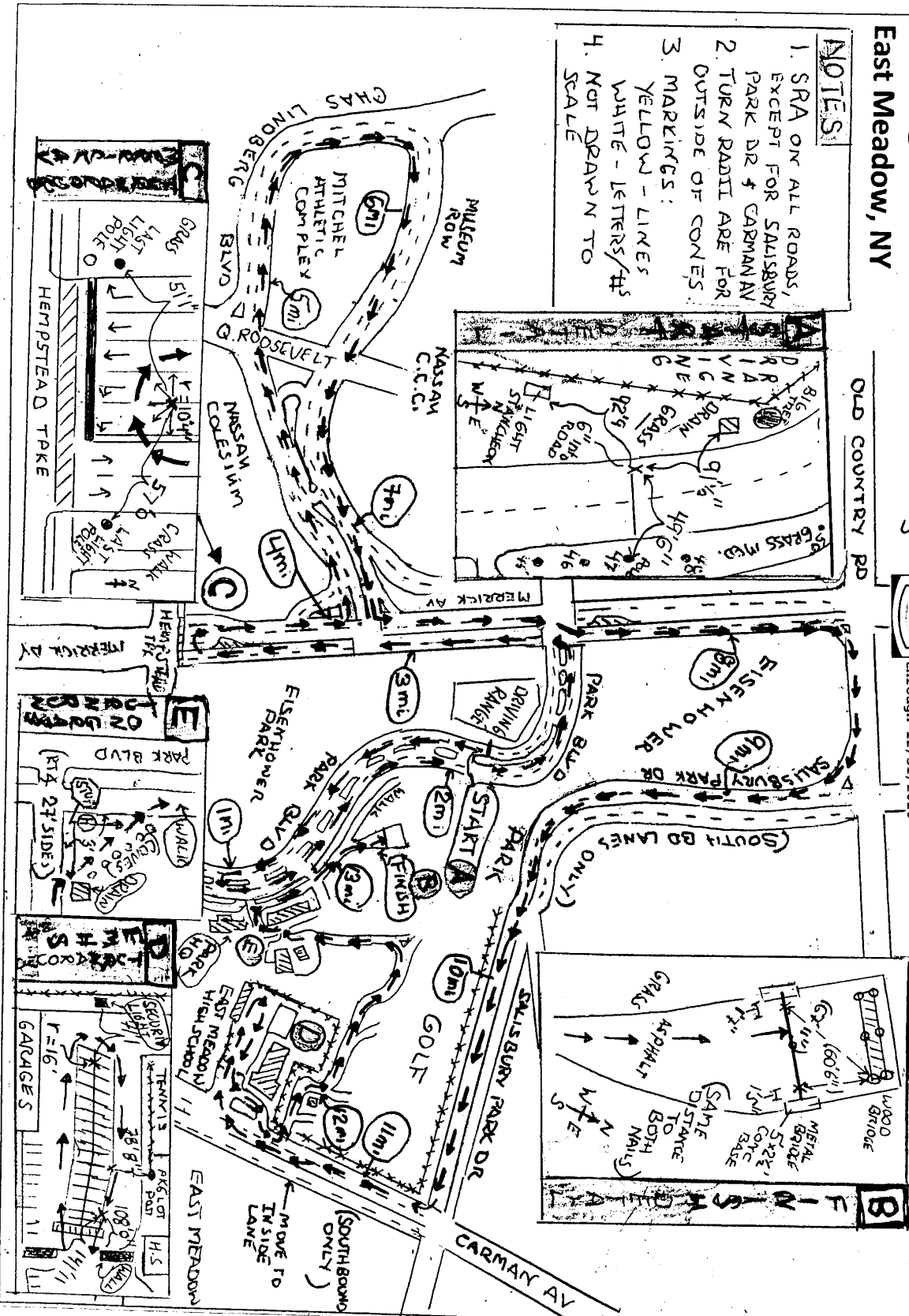
