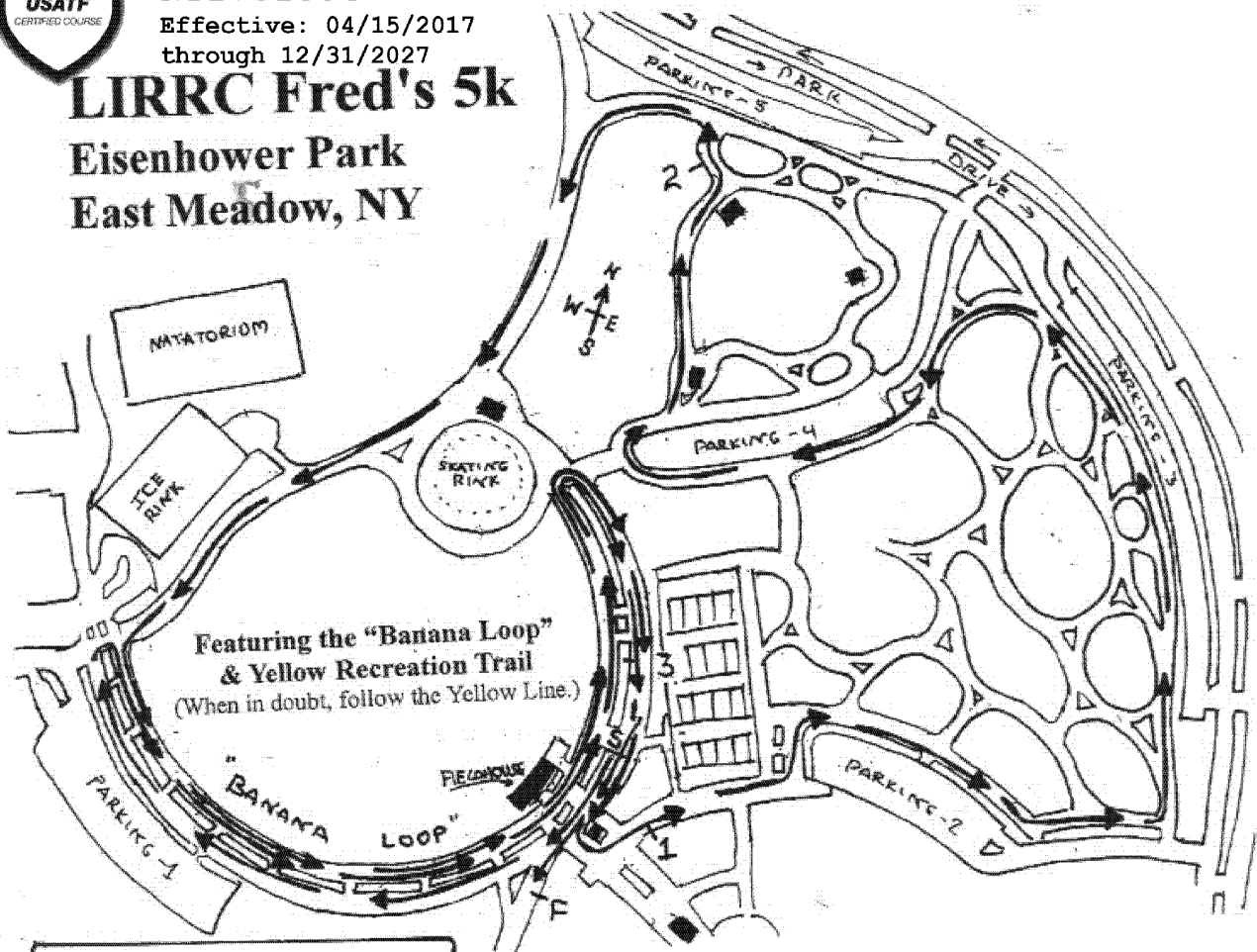

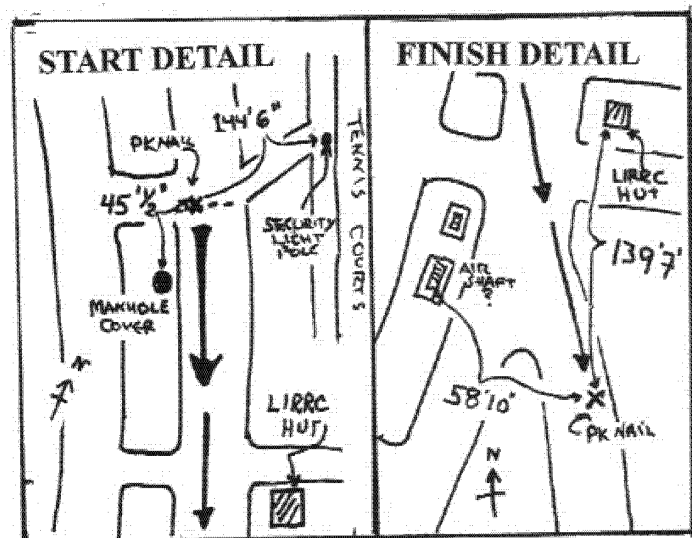
**Start:** Northeast of the Fieldhouse and LIRRC Hut.
